The Client and The Company agree as follows:

1. The Services

A. K. Colfer Sporthorses LLC will provide client with

- access to (please choose one) 1 2 3 riding lesson(s) per week
- Two, 2 hour, unmounted group horsemanship classes per year- Winter and Summer.
- Two, 30 minute, private goal setting sessions per year- Spring and Fall.
- The riding lessons will either be a 30 minute private, or 1 hour group of 2 or more.
- Access to our private You Tube channel, so learning can continue at home.

B. K. Colfer Sporthorses LLC will be closed 5 weeks per year to give the lesson horses a break, allow students to have holiday and travel plans without missing lessons, and to run special events such as camps clinics etc. The weeks that are off will be communicated each year to our current students via email and posted in the barn. They will generally fall on Thanksgiving, Christmas, Spring break, 4th of July and one week in October. For 2023-24 they are as follows

2023- March 27-April 2, July 1-7, October 21-28, November 20-26, December 23-30

2024- March 24-30, June 30- July 6, October 19-25, November 25- December 1, December 22-28

- Other travel for horse shows, horse purchasing etc. may be required either a substitute instructor will be provided or make up lessons will be scheduled.

C. Riders will be automatically grouped together with riders of similar ability. This is paramount to our barn culture and philosophy of creating a community that encourages camaraderie, friendship and support. We feel this leads to higher quality riding, lessons, and more fun.

2. Client Requirements

- A. Client must show up on time.
- B. Client must be wearing proper riding attire- English riding boots with heels, leggings or breeches, and helmet. The barn can provide a helmet and paddock boots to new riders.
- C. Client must be coachable, positive, and have a good attitude!

3. Compensation and Payment Terms

- A. Our monthly tuition price is based on the annual value. Client will put a credit or debit card on file, and it will be automatically charged each month for the chosen tuition plan.
- Basic riding school tuition \$215 for 1 lesson per week
 - Premier riding school tuition \$420 for 2 lessons per week
 - All Star riding school tuition \$630 for 3 lessons per week.
 - Charges will begin on the first day of enrollment and continue every month thereafter.
- B. In order to make meaningful progress in any endeavor- there must be a minimum commitment level. Riders must agree to a 6 month minimum term. Early cancellations will be charged a \$100 cancellation fee.

4. Scheduling

- A. Client will receive a dedicated time and a day of the week where there will be an appropriate school horse for their use, or their owned or leased horse. They will be either scheduled for a private, 30 minute, lesson or a group, 1 hour lesson, with riders of similar abilities each week. Please remember that K. Colfer Sporthorses will be closed 5 weeks per year.
- B. If client cannot make their scheduled lesson- K. Colfer Sporthorses will allow a maximum of two makeup lessons per month- provided that client cancels by texting or calling 231-838-9386, 24 hours prior to the lesson.
- a. All makeup lessons will take place on Saturdays between 10:00AM and 1:00PM when there is no United States Pony Club programming. A schedule for when makeup lessons are available will be posted in the barn no later than 08/31/2022
 - b. Makeup lessons are not guaranteed and are up to the client to schedule. If a lesson is not made up within 30 days it will expire.
 - c. Late cancellations and no shows will not have an opportunity to make up their lesson.
- C. Monthly tuition is still due, in full, if a student misses their lessons. The monthly fee is based on yearly tuition, and while some riders may attend all of their lessons we expect, and have accounted for riders that may miss lessons due to scheduling conflicts, illness or other personal reasons.
- D. In the event that the weather prevents riding- unmounted horsemanship lessons may be substituted. In the event that weather prevents the barn from being open- Make up lessons will be offered as stated above.

The best way to get the most value out of the program and to progress your skills as a rider is to make it a priority and a commitment not to miss your dedicated lesson time(s).

- E. If client would like to make a long-term change to their dedicated lesson time, they may do so on a space available basis by texting 231-838-9386.
